Dream On envisions a world where freedom from slavery is an indomitable right from birth and access to basic human rights paves the way toward fulfillment of dreams and aspirations.

Program Service Accomplishments

Total amount contributed toward programs in Ghana – \$92,532

Dream On International (DO) operates in many locations throughout Ghana to provide rehabilitative care and protection for children who have been victims of human trafficking, sexual violence, and child labor. Dream On collaborates with several private schools, non-governmental organizations, and the Department of Social Welfare (DSW) in Ghana to ensure children are enrolled in day or boarding schools and receiving proper supervision, shelter, security, food, educational provisions, medical care, and emotional support.

In 2018, Dream On continued to operate the Dream On Residential Home in Accra, Ghana. The home serves eight young adults who are full-time residents and eight additional young adults who join the home during holidays and vacations from boarding school.

Dream On also focuses on preventative measures to help children who are on the brink of becoming orphaned or sold into slavery. Often times, a child is one illness away from losing his/her parents, or one day away from being sold into slavery. Our goal is aligned with DSW's mission, which is to keep children in the home with their families as often as possible. This year, Dream On concentrated its preventative efforts on educational and medical sponsorship.

Details of Program Spending in Ghana:

Prevention Sponsorship: \$ 20,240

Preventative scholarships are granted to students in various regions of Ghana. We currently have children enrolled in 16 different schools throughout Ghana.

Rescue Sponsorship: \$ 11,936

This amount includes day and boarding fees for children attending several different schools in Ghana at the junior and senior high school levels and college.

Golda Meir Academy: \$4,200

This amount includes sponsorship of children and teachers' salaries.

Dream On Residential Home: \$50,044

Operational expenses of the Dream On Residential Home including food, rent, electricity, water, medical care, etc.

Rescue Missions: \$0

There were no missions to remove children from abusive situations in 2018. We focused on maintaining the care of children who were already being supported through rescue sponsorship.

Goods for Children: \$ 6112

Vitamins, medicine, toiletries, clothing, and electronics such as computers, phones, chargers, carry cases, etc.

Groundbreaking Research on Sex Trafficking in Nigeria

Total amount contributed toward research – \$5,758

The president of Dream On conducted a research study on the epidemic of sex trafficking from Nigeria to Europe. The study is titled "Bound by Silence: Psychological Effects of the Traditional Oath Ceremony Used in the Sex Trafficking of Nigerian Women and Girls." The research was published in Dignity: A Journal on Sexual Exploitation and Violence Against Women.
